Registration is from 1:00 PM to 1:15 PM. The meeting will promptly start at 1:15 PM.

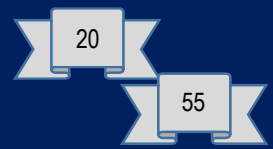

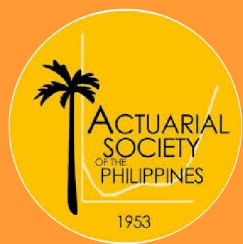
